#### A. Individual Registration

- 1. Green barcoded ID or smart ID card (Back and Front)
- 2. Valid foreign passport for non-SA citizens
- 3. Valid South African Driving Licence (Back and Front)
- 4. Valid traffic register number for non-SA citizens
- 5. Proof of residence not older than 3 months (unless otherwise specified) such as.
  - Utility bill (water, lights, rates, taxes) (This is the ONLY type of Tax Invoice that is acceptable)
  - · Municipal Letter from a Municipal representative confirming residential address e.g. Ward Councillor
  - Correspondence from a Body Corporate / Share Block Association e.g. Levies Statements
  - Bank statements (No FNB or Wesbank related statements or documents)
  - Retail or clothing account statements e.g. Edgars, Woolworths, Jet, MrPrice, Truworths, Markhams, Foschini, Ackermans, Legit
  - · Cell phone or landline monthly statements e.g. MTN, Vodacom, Telkom, Cell C
  - Rental / Lease Agreement (Usually valid for 1 year)
  - Mortgage (Bond) Statement (No FNB or Wesbank related documents)
  - Wi-Fi or DSTV Monthly Statements
  - Medical Aid/ Health Insurance Monthly Statements e.g. Discovery, Clientele, Funeral Policies, etc.

#### **Documents not Acceptable:**

- Payslips / Salary Advice from an Employer
- IRP5
- Sars eFiling Print Screens
- · Insurance Confirmation on new vehicles being purchased
- Tax Invoices e.g. Doctor, Pharmacy, Florist, Purchases
